

FREE GAS CARD OFFICIAL RULES

1. ELIGIBILITY: Wallace Finance's \$50 Free Gas Card ("Sweepstakes") is open only to legal residents of the forty-nine (49) United States and the District of Columbia (void in Rhode Island, Puerto Rico, all U.S. territories and possessions and all overseas military installations) who are at least eighteen (18) years of age or older as of August 1, 2022. All employees of Wallace Finance ("Sponsor"), and all associated agencies and each of their respective affiliates, sales representatives, distributors, licensees or agents (all of the foregoing, together with Sponsor collectively, "Sweepstakes Entities"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether legally related or not), are ineligible to enter or win the Sweepstakes. All applicable federal, state and local laws and regulations apply. Void where prohibited by law. 2. SWEEPSTAKES PERIOD: The Sweepstakes entry period begins at August 1, 2022 (the "Sweepstakes Period"). Winners will be selected from entries properly submitted during the Sweepstakes Period.

3. SWEEPSTAKES ENTRY INSTRUCTIONS: There are two (2) separate ways to enter this Sweepstakes: either through a Physical Entry (defined below) or by automatically by referring a customer to Wallace Finance who successfully completes a transaction with Wallace Finance within the eligibility period. However, entrants may only receive a maximum of one (1) total entry per day during the eligibility period regardless of the method of entry they choose. Any attempts by an entrant to submit more than one (1) entry per day during the eligibility period will result in such entrant being disqualified. During the Sweepstakes Period, you may submit an entry at participating Wallace Finance store locations ("Physical Entry"). Entrants must provide the following information to a participating Wallace Finance location: name, address, city, state, zip code, date of birth, and valid telephone number, Physical entries must be submitted between August 1, 2022 and October 30, 2022 to be included within the random drawing.

Entrants are encouraged to make certain the phone number provided to Wallace Finance is accurate to ensure timely notification in the event that the entrant is randomly selected as the Grand Prize Winner.

5. SELECTION OF SWEEPSTAKES WINNER: The potential Winner will be selected in a random drawing to be held on the 5th business day of each month. The potential Winner will be selected from all eligible entries received during the Sweepstakes Period of the previous calendar month. Odds of winning will depend on the number of eligible entries received during the Sweepstakes Period. The potential Winner must be available by telephone at the time of the announcement on the 5th business day of each month in order to claim the Grand Prize. The potential Winner will be notified via telephone to the telephone number submitted with his/her entry the day of the drawing ("Prize Award Period"). The drawing will be conducted by Sponsor, the judge of the Sweepstakes, whose decisions on all matters relating to the Sweepstakes shall be final and binding. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: (1) potential Winner's failure to respond to telephone notification within during the first attempt of transmission on the 5th business day of each month; (2) potential Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; and (3) any other non-compliance with the Official Rules. In the event of a prize forfeiture, the Sponsor may, in its sole discretion, award or not award the forfeited prize to an alternate winner.

6. PRIZES: One (1) "Grand Prize" will be awarded to the "Grand Prize Winner", which will include: 1 (one) prepaid gas card in the amount of \$50.00. Total ARV \$50.00 (US). All taxes are the responsibility of the Grand Prize Winner. Grand Prize Winner subject to the Terms and Conditions associated with the use of the prepaid credit card, issued and maintained by a third party and not the Sponsor.

Prize is not redeemable for cash (except as required by law). No substitution allowed except, at Sponsor's sole discretion, a prize of equal or greater value may be substituted. The prize will be awarded provided it is validly claimed by the 10th business day of each month, after which no alternate winner will be selected, nor unclaimed prize awarded.
